Many members signed the petition of support that I took to MP Borys Wrzesnewskyj's office for him to present in the House in the time allotted for petitions.



ETOBICOKE RESOLUTIONS DISCUSSION

The following decisions were made at our March Resolutions Discussions meeting:

DRIVE-THROUGH SERVICE

Proposed by CFUW Toronto

RESOLVED, that the Canadian Federation of University Women (CFUW) urge federal, provincial, territorial and municipal governments to create and enforce standards, either through regulation or law, to control the idling of motor vehicles.

ACCEPTED.

CRIMINALIZATION OF NON-STATE ACTOR TORTURE

Proposed by International Relations Committee

RESOLVED, That the Canadian Federation of University Women (CFUW) urge the Government of Canada to amend without delay the Canadian Criminal Code to include torture committed by private individuals (non-state actors) as a specific and distinct criminal offence.

RESOLVED, That CFUW urge the Government of Canada to (i) exercise due diligence by initiating into Canadian policies and practices without delay all appropriate measures to ensure that women and girls (who are disproportionally affected by extreme forms of violence), and men and boys are not subjected to torture by non-state actors in the private sphere, (ii) respect the high priority of establishing gender-sensitive frameworks on the global United Nations agenda, and (iii) uphold Canada's commitments to applicable United Nations human rights instruments to which Canada is a signatory.

Amend Clause 2 (i) by

Striking out the words "...women and girls (who are disproportionally affected by extreme forms of violence) and men and boys are not..."

Inserting the words "no one is"

The amended clause to read: "... all appropriate measures to ensure that no one is subjected to torture..."

Amend Clause 2 (ii) by

Inserting the words ... "given that women and girls are disproportionally affected by extreme forms of violence." after "... United Nations agenda."

Otherwise accepted.

It was felt that this resolution would benefit from clarification in this context of "due diligence", possibly reinforced by a legal opinion.

CFUW Ontario Council Standing Committee Meeting - March 19, 2011 Status of Women

The speaker for the Status of Women Standing Committee was unfortunately unavailable. Instead, Chair Rhea Pretsell spoke to us about her experience attending the Equal Voice conference which took place at the Ottawa Convention Centre March 12, 2011. The conference was attended by more than 200 women from all parties. Pat Carney was in attendance as well as members from a feminist Quebec separatist group, the speaker for the afternoon session for the Status of Women, and Human Rights representatives from the aboriginal women.

The event coincided with the 10th anniversary of the founding of Equal Voice and the 100th anniversary of International Women's Day. The focus of the conference was "Why we need more elected women in government". Even though women represent 52% of the population, only 22% of the M.P.s in Canada are women. They speak only 7% of the time.

By the United Nations standards to be a "critical mass" women should hold 33% of a government's seats. When Equal Voice was formed 10 years ago there were 20% women M.P.s; at this rate it would take many years to hit the 33% threshold that Equal Voice has as its next 10 year goal. What can we do to ensure that this is attainable?

We can support women who do run for election by fundraising and canvassing for the candidate. Help must come from women. We can encourage women to vote by offering to take them out to vote. We can help immigrant women to understand their voting rights.

There are many obstacles for women who have the desire to enter public life. Many have no child care options or the money it takes to run for office. There are many domestic reasons and women have different priorities in their lives. Sixteen hour days are very difficult for women who have a family. When Pat Carney was asked how to have a political life and a family life, she responded "Don't even try". It is often difficult for women to win a riding as they are often put up against a strong incumbent.

We were asked to consider whether CFUW was a good fit with Equal Voice. The Federation of Municipalities has undertaken a goal of 33% women in municipal governments, however the provincial and federal governments have no goal. Some countries in the world have it constitutionally. Do we have or want policy to this effect? Do we want to urge the governments to set a goal?

The Chair gave us an update on our January 2011 speaker Sabina Ali from the Thorncliffe Park Neighbourhood Women's Group. She has accepted an invitation from CFUW Orillia member Dorothy Macdonald to be her guest at the Canadian Club's April 27th Equal Voice Award celebration. Isabel Bassett, Dorothy Macdonald's sister-in-law, will be the recipient.

We also heard an update on the province's Sexual Violence Action Plan which has been ongoing for five or six years . Ontario Council made recommendations at the end of August 2010 and the final report came out in early March. Critics of the report say that it is fixing the problem after the fact. Jane Doe has said that the responsibility of males has not been sufficiently addressed. The government wants to concentrate on younger women, but, as we know, sexual violence does not discriminate: infants and the very elderly are victims too. Rape crisis centres are not happy with the report as they only receive 5% of the budgeted \$15 million, which does not make up for the loss to these centres during the Harris government.

CFUW Ontario Council Standing Committee Meeting - March 19, 2011 Morning Session on Financial Literacy

Speaker Greg Pollock, former teacher, former CEO of the Catholic Teachers' Organization, presently director of an umbrella organization of financial planners, was one of 13 members of an expert panel assembled in 2009 by Finance Minister Flaherty to advise on a plan of action to promote financial literacy in Canada. Financial Literacy is defined as "having the knowledge, skills and confidence to make responsible financial decisions". The need for such a program is demonstrated by a number of factors:

- increase in household debt (the average family debt in Canada has increased from \$5,800 in 1990 to over \$100,000 today, and is greater than that in the U.S.).
- the need to make financial decisions at an earlier age (use of credit cards, phone plans, etc.).
- ramifications of the shift from Defined Benefit to Defined Contribution pension plans.
- the increasing need for Canadians to fully participate in financial matters.
- Only 60% of Canadians contribute to an RRSP.
- · Only 38% of Canadians feel their financial circumstances will improve in the next year.

The Panel's mandate was to deliver a national strategy, and to determine how to marshal resources to implement the strategy. It identified five priorities:

Shared responsibility: among public and private sector, labour, volunteer sector, financial services, etc.

Leadership and collaboration: a leader is required, who will pull together all relevant ministries and other elements.

Delivery and promotion: by websites, awareness campaigns, self-assessment tools, clear language on tax forms, credit card applications, mortgages, etc.

Accountability: constant monitoring and evaluation of progress.

Lifelong Learnng: foundation should be built in school, (Ontario is proposing adding financial literacy to its grade 4 to 12 curriculum), but should be continued in the workplace, market place and financial services industry, and government programs.

Mr. Pollock admitted that hurdles exist in the way of any financial literacy program solving individual financial woes:

- · People behave irrationally and make bad financial decisions despite knowledge.
- People do not take advantage of programs available to them; (160,000 eligible seniors do not get OAS, 150,000 do not get GIS, 55,000 do not get CPP, most do not take full advantage of RRSPs.

The panel's report was delivered to the government in February 2011, and the government has not yet decided on whether to implement its recommendations. Mr. Pollock believes that if they are implemented, success of the operation will result in a better quality of life for Canadians, resilient households in good times and bad, and a more competitive Canada.

Afternoon Session: Legislation Standing Committee:

The afternoon speaker was Kim Pate, executive director of the Elizabeth Fry Society, speaking on women in prison. She excoriates the government's proposed new law and order legislation as useless rhetoric, but all parties have bought in, as they can't be seen as soft on crime.

Women are the fastest-growing prison population, but these are predominently poor women, victims of what Ms. Pate calls the criminalization of poverty. Some reasons are:

Marginalization: Women still make less than men, and with the elimination of the Canada Assistance Plan, there are fewer financial supports for them and their children. She claims that it is impossible to survive on social assistance, so that women must cheat to live as the system is stacked against them (e.g. money borrowed by one on social assistance must be declared as income, but cannot be claimed as a deduction when paid back). 82% of women in prison are there for fraud, prostitution and drugs, all survival tactics.

Mental Health and Addiction Issues: These affect 50% of female prisoners who should properly be treated in mental health facilities rather than prison. Instead they are placed in maximum security for such misdemeanors as trying to escape, or being hard to handle, which only makes them worse. Many have a history of abuse and use drugs to euthanize themselves, or are given drugs to keep them placid.

Aboriginal women are disproportionately affected. They are imprisoned nine times more than other women, and often plead guilty to offenses for which they might offer a defence in plea bargains in order to mitigate their sentences.

The cost of the Corrections system is rising, (we don't know by how much, due to lack of transparency by the federal government) and will be substantial. One of several "law and order" bills contemplated by the government, eliminating credit for time served, has been costed at five billion dollars a year by a panel of economists. If more services were offered in the community to alleviate poverty and other social ills, Ms. Pate speculates that 75% of women could be released from prison, saving the \$175,000 it costs to keep a woman in prison for one year (\$350,000 to \$500,000 in maximum security), freeing funds for mental health services, child care, tuition and social assistance. She feels we cannot afford not to deal with these issues.

Education Standing Committee

Since 1957 Social Planning Toronto has engaged in research, policy analysis, community planning, and capacity building. Executive Director, John Campey, reported on a symposium held last September that brought together a broad range of 250 people from across the province to discuss Schools as Community Hubs: The Vision, The Challenge, The Opportunity. Mr. Campey who has been an educator and school trustee brings his personal experience to the topic.

The central role of the school in the wider community has a long history in Ontario. This central role has lessened and schools have become single purpose facilities. Declining enrollment, particularly in older neighbourhoods in Toronto, has prompted exploration of the use of schools as community hubs with services for families and the community under one roof. There are a number of schools that were built to serve 600 students that now have enrollments of 200 to 300. Rather than closing these facilities a number of services for all ages such as daycare, adult education, immigrant services, and public health services could be located in the school strengthening the community. Community consultation is key to addressing the particular needs of each area and coordination of the various government ministries involved requires dedicated leadership. The Toronto District School Board currently has pilot projects underway.

The local school should be a vital community resource, not a disposable real estate asset. Do you have a school in your community that may close? Contact your local school trustee for information.


