# Ontario Council Standing Committee Reports, September 29, 2012

## **Morning Session**

Speaker Irwin Elman is Ontario's first Provincial Advocate for Children and Youth, a position he has held since 2008. Mr. Elman has an extensive background as an educator, counsellor, youth worker, program manager, policy developer and child and youth advocate, for the CAS and CCAS and with other groups in Ontario, Jamaica, Hungary, and Japan. The Youth Advocate office reports directly to the legislature, not through a minister, and describes its purpose as:

4

- 1."Provide an independent voice for children and youth including First Nations children and youth and children with special needs by partnering with them to bring issues forward"; and
- 2."Encourage communication and understanding between children and families and those who provide them with services"; and
- 3." Educate children, youth and their caregivers regarding the rights of children and youth, (referencing the U.N Convention on the Rights of the Child and assessing Canada's progress in applying the Act)."

Mr. Elman sees himself as "walking beside children and youth in care" (includes Crown Wards, as well as youth with special needs and First Nations youth, not other youth in trouble, at school, for example) giving them a voice to bring their issues forward, and acting as an exemplar of "meaningful participation" for them. He does not do research, or impose solutions or decisions on youth: he facilitates their using their own voices to express what is best for them.

Children taken into care are there until age 18, or 21 if in school, often being moved from foster home to foster home, and school to school, preventing any stability or cohesion in their lives. Only 40% of Crown Wards graduate from high school, and 47% of street youth have child welfare experience. At 18 they are on their own, not having acquired the basic life skills that come from a stable family: cooperation, work ethic, responsibility for chores, etc.

Mr. Elman discussed his work under three headings:

**Resources:** help with practical things (finding a job and housing, money); accessing resources from government sources and agencies.

**Connections:** making up for the lack of connections that come from a stable environment. They work on the "One Person Theory", that it is important for one to have one person they can relate to: The Advocate Office tries to provide that one person.

**Voice:** Resources and Connections are useless if young people have no voice or control over their lives, and have no experience to help them make good decisions for themselves.

His role is to talk to, and listen to, young people on their issues, and facilitate

their contact with governments and others who can help them. He points with pride to recent hearings held by youth leaving care at Queen's Park, attended by ministers of several departments, at which the kids told their stories and aired their concerns. This resulted in a report and a working group to come up with a blueprint for reform.

We were urged to pressure the Ontario government to create fundamental change, and urge all sectors (professional groups, unions, etc.) to work to change the system.

## Status of Women and Human Rights - chaired by Cheryl Ambrose,

Our new Chair introduced us to the theme of Ways to Collaborate with other Women's Groups in our Communities.

CFUW Kitchener-Waterloo decided to form a group which would focus on women, share resources, and support advocacy for issues. Last year, Past-President, Ruth Russell, launched the "Women's Network of Kitchener-Waterloo and Area". Two members, Elizabeth Simpson and Barbara Spronk, attended our afternoon meeting to speak to us about this umbrella organization for all women's groups in the area. The Network has had three breakfast meetings, which were hosted by a different organization each time. They also have set up a virtual network where members can access and post their organization's events.

CFUW Oakville has a collective of twenty groups and social agencies called "Advancement of Women Halton". Anne Douglas reported that the group has early afternoon meetings once a month to which organizations send a representative, often as part of their work, or as volunteers. This non-partisan group is action-oriented in writing letters, partnering with other groups on the same issues, using a newsletter to convey news from their organizations to others, and holding a successful International Women's Day fundraiser dinner.

Both Clubs suggested that holding common events helps to consolidate the new group. Another idea was to have a well-known person involved so the group has credibility in the community right from the beginning. And it's important to contact all the women's groups in the area so every organization is invited to join.

# Legislation Standing Committee - Meeting chaired by Brenda Robertson.

The Chair announced that, at this time, the group is currently looking for a new Chair, as Jane Sagar, who has held that position, has had to step down due to health and family responsibilities.

We began with a round table that included introductions as well as a statement of issues each club is working on: these included poverty, aboriginal education, child care, transit, financial literacy and mental health to name just a few.

The session was about **Youth in Care.** It was lead by two youth who are part of a working group that has been set up under the auspices of the Provincial Advocate for Children and Youth. The young man and young woman, both in their early twenties, were children in care. The working group has been established to give voice to youth about the systemic problems that exist for children and youth in care, i.e. Crown Wards. They spoke about the numerous moves from home to home, their lack of a sense of belonging, their isolation and their vulnerability. They told us that when you are in this system, you develop the sense that you have no control over what happens to you. You don't develop the life skills or the decision making skills that are needed for independence.

They outlined the policy of being "terminated": that is the term that is officially used when these youth become "of age" and are no longer the responsibility of the Province. The ages of 18 years and 21 years are significant – at 18, you must leave your foster home or group home and find your own place to live. If you are still

going to school, you may receive a stipend until the age of 21 years at which time that is "terminated". Once terminated, you have no home and no money – you are financially and emotionally on your own. As a result, few of these youth are able to successfully complete their education and are, therefore, disadvantaged as they move into their adult life.

In an attempt to make the policy makers aware of these problems and to give youth a voice, the Provincial Advocate set up "Youth Leaving Care Hearings". These were held at Queen's Park in the fall of 2011 and attended by government ministers, deputy ministers ,and ministry and agency personnel. Through presentations, videos, poetry and art youth shared their experiences. Out of this, a booklet titled "My Real Life Book" was created. Youth are looking for fundamental change in the system and are expecting an action plan from the provincial government by November 2012.

# Education Session co-chaired by Myrtle Greve and Arlene Midriak

CFUW members attending the session introduced themselves and gave a brief outline of the issues that their clubs are working on. A wide range of issues are being addressed: Aboriginal education, homecare, Fetal Alcohol Spectrum Disorder, women in non-traditional occupations, Afghan women, poverty, childcare, and responding to issues that arise in their communities. Our Issues Group has been researching public transit and has had meetings with councillor Peter Milczyn and a senior planner from the TTC. The Toronto Caucus's study of poverty led to their decision to concentrate on early learning and childcare and a plan for a CFUW campaign in support of a national childcare program.

Our speaker was **Martha Friendly**, the founder and Executive Director of the **Childcare Resource and Research Unit**. She has authored numerous articles and reports on childcare, a book on childcare policy, and participates in several child care advocacy groups.

Her topic was: **From vision to action: Putting the pieces together for a national childcare program.** She presents a compelling case for a nationally co-ordinated childcare program that enables parents to participate in the workforce, supports child development and learning, and supports wider community goals such



as alleviation of poverty, social inclusion, and development of human capital. She sees a vision of a mature publicly funded system in place by 2020. The funds would come from the federal as well as provincial governments and would not be a system of subsidies, vouchers or cheques as is the case now. Fees would be charged but they would be affordable. Childcare delivery would cease to be a private commodity and become a public responsibility. CFUW and other community groups have been working on this issue since the 1970s and will continue.
